1. Artist must be a member in good standing of the Valley Art Association. **Fee must be received on or before May 15<sup>th</sup>.** Artist will receive confirmation from the VAA of payment received and hanging dates.
2. An Artist fee of \$ 20.00 will be charged to exhibit 2 pieces of art in the exhibit. An artist may exhibit 1 or 2 additional pieces of art for an additional \$5.00/piece. There is limited space so this will be determined by the number of artists participating. Artwork will remain in possession of Elmaro Vineyard during the exhibit. Sold pieces may be replaced. The coordinator will notify the artist when/if a sale occurs.
3. The artist is responsible for delivering and pick up of their artwork. If this is not possible for you, contact Lindamerry to make arrangements for delivery and pick up of art work
4. All artwork must be the artist's original artwork, prints and embellished prints of original art are accepted but must be identified/ labeled as prints. Artwork does not need to be for sale - indicate NFS on your inventory sheet.
5. All art will be screened by VAA coordinator for suitability at set up time. If artwork is not accepted the artist will be able to replace the unaccepted artwork.
6. All artwork must be exhibition ready with proper hanging/display hardware. (No sawtooth hangers). VAA coordinator will hang artwork.
7. Artist must have each piece labeled on the back with artist name, title, original or print, media, size and price. The attached inventory form must accompany the artwork when delivered to Elmaro Vineyard. VAA will provide display labels.
8. Elmaro Vineyard will do everything possible to safeguard and protect all artwork from loss or damage. The artist is totally responsible (including insurance) for the art displayed and will not hold the VAA/ Elmaro Vineyard responsible for any damages or theft of their work. Elmaro Vineyard carries limited liability for property in the case of catastrophic events such as fire, storms, etc.
9. Elmaro Vineyard will not take a commission. All credit card transactions will be subject to a 3.9%, so price accordingly. Elmaro Vineyard is responsible for collecting and filing all sales tax.
10. VAA/ Elmaro Vineyard will provide marketing, promotional materials, web presence and push out of the work.

**Exhibit fee of \$20.00 must be made payable to VAA and sent to the VAA treasurer PO Box 674, Chippewa Falls, WI 54729 by May 15<sup>th</sup>.
